- out of the Board of Trustees by himself or is removed from that office by the Board of trustees. The Managing Trustee shall also be called Chief Functionary which post is synonymous with that of the managing trustee for all the purposes of this trust.
6. The original trustees shall continue to have the power to appoint additional trustees to the Board of trustees, subject to clause seven hereunder, so long as the total number does not exceed the upper limit. They may also fill up any vacancy that arises in Board of trustees as and when they deem necessary. All trustees newly appointed, whether on a casual vacancy or as additional trustees shall have the same power as that of the exiting trustees as at the time of such appointment.
 7. All additional trustees as and when appointed shall retire by rotation and the rotation period shall always be three years. New trustees can be appointed only as additional trustees and such additional trustee as a role shall also retire every three years on a continual basis. A trustee, against whom a removal/dismissal action is being contemplated by the Board of trustees, shall not have voting power on resolutions proposed for his removal/dismissal.
 9. All resolutions of the Board of trustees shall hereafter be taken on a simple majority unless otherwise specifically stated in this deed, and the Chairman shall always have a casting vote in case of a tie.
 10. The administration of the trust and the entire control, supervision, regulation, and management of the trust property and the application of the entire or a part of the income and profits hereof as also of all the donations and contribution, and all other receipts shall continue to vest in the discretion of the Board of trustees.
 11. The Board of trustees may frame rules and regulation for the administration of the trust and for carrying out the purpose and objects thereof, and the same may be varied, altered, deleted substituted or added to, from time to time by a majority decision of the Board of trustees, with a view to introduce more effective administration. All such rules and regulation already framed shall continue to be in force.
 12. The Board of trustees or any person authorized on that behalf by them is empowered to accept donations, contributions, in cash or in kind and any other receipts, with or without any special conditions do not contravene in any manner the objects of the trust. Without

18. The Managing trustee shall carry out all the decisions of the Board of trustees and make reports to the Board on progress functioning and other aspects of the working of the trust.

28. If the trustees at any time are of the unanimous opinion that the affairs of the trust cannot be carried on for any reason whatsoever, then they may transfer all the properties and assets to another trust with similar objectives and in no case shall it be distributed among the trustees or the beneficiaries.
29. Any provision contained in the deed may be altered in order to remove any doubts or any unforeseen obstacles or want of power to the trustees provided that such alteration may be made only for the purpose of giving full effect to the purpose for which this trust is created and such alterations are unanimously approved by the trustees provided however, no amendments will be made to the trust deed without the prior approval of the Commissioner of Income-tax under whose jurisdiction the trust functions.
30. That the Managing Director of the Trust shall also act as the information officer of the Trust and shall be responsible give all the information, if any asks for.
31. This deed is to be registered before Sub-Registrar Solan, District Solan H.P.

The Trustees shall be indemnified against all losses and liabilities incurred by them in the execution of the Trust and shall have a lien over the funds and properties of the Trust for such indemnity.
